### Legislative report for April Newsletter

- ❖ On March 4, a Federal Appeals court allowed Texas SB4 Immigration law to take effect. The next day it was suspended once again at the 5<sup>th</sup> circuit court of appeals. On March 27, the Appellate court upheld the ruling to keep SB4 on hold. The court will hear the case in the first few weeks of April.
- ❖ Tennessee Gov. Bill Lee has deployed soldiers from the Tennessee National Guard to join Texas counterparts in Operation Lone Star to bring more security to the border. The Governor said he asked for 100 soldiers to assist the effort but says that nearly 400 volunteered.
- ❖ On March 4, the U.S. Supreme court ruled unanimously 9-0 that Colorado nor any state has the right to remove Donald Trump from their ballots.
- ❖ On March 26, the United States Supreme Court heard oral arguments on a case by the FDA to expand access to the abortion pill, Mifepristone. The Drug was approved by the FDA in 2000. The FDA is wanting to make the drug more accessible to women and allow it to be taken later in pregnancy past the 7 weeks up until 10 weeks and be able to order and deliver through mail without a prescription. The case comes from a Texas Based U.S. District Judge and a group of anti-abortion rights doctors that are challenging the FDA's approval and has invalidated it's approval calling it unlawful. No decision has been made yet.
- ❖ **TEXAS** — A group of Texas Republicans on Wednesday introduced a resolution opposing a Democrat-led bill that would connect the Texas electric grid to national power grids.

The resolution says the Electric Reliability Council of Texas (ERCOT) “is not subject to the jurisdiction of the Federal Energy Regulatory Commission, rather falling under the jurisdiction of the Public Utility Commission of Texas and the Texas Legislature.”

Rep. Randy Weber, R-Friendswood, wrote the resolution and Reps. Troy Nehls, R-Richmond, Pat Fallon, R-Sherman, John Carter, R-Round Rock, Keith Self, R-McKinney, Michael Burgess, R-Lewisville, and Tony Gonzales, R-San Antonio, cosponsored it.

“In Texas, we proudly maintain our own electric grid—overseen by Texans, not the federal government—and we intend to keep it that way,” Weber said. “Some of my Democrat colleagues had a brilliant idea to lasso the state into the national electric grid, filled with its own challenges and failures. I will continue to fight to ensure that Texas’ grid stays in the hands of Texans and not bureaucrats sitting in Washington.”

Rep. Greg Casar and fellow Democrats Rep. Jasmine Crockett, D-Texas, Rep. Joaquin Castro, D-Texas, and Rep. Alexandria Ocasio-Cortez, D-New York, introduced a bill in February that would require Texas to connect to the national power grids and require addition oversight from the Federal Energy Regulatory Commission (FERC)

The Connect the Grid Act was introduced on the third anniversary of the February 2021 winter storm, which left Texans in the dark and without power in freezing temperatures when the ERCOT grid nearly failed entirely. The official death toll from the incident is 246.

Casar said Republicans are founding the “pro-blackouts caucus” through their opposition of the bill.

He also noted that the East Texas region that Weber represents is not connected to ERCOT. That region did not lose power during the 2021 winter storm.

Through the Connect the Grid Act, ERCOT would still oversee running the Texas power grid, along with Public Utility Commission of Texas (PUC) and the Texas Legislature.

In a post to X, formerly Twitter, Weber criticized the bill, calling the attempt to connect the grid to the rest of the U.S. “communist style thinking.”

“Federalizing Texas’s electric grid = Typical government bureaucrat-style thinking, even communist-style thinking - the big, overblown government needs to control everything. I will continue to fight to ensure that Texas’ grid stays in the hands of Texans & not bureaucrats sitting in Washington,” Weber said.

Ladies can go on Tuesdays and shoot all day for \$10. Other days are \$25 per hour for 1st shooter and \$10 per hour for each additional shooter using the same lane. So, Tuesday is definitely a good day to go. We can share a lane. Probably no more than 4 per lane would be best, depending on how many of us go.

If you don't have a gun, or want to try one out, about 30 guns are available for rent. If you know of a gun you want to try, let me know

in case my daughters or I have that caliber. That way you would only have to pay for the ammo. If you rent a gun, you must use their ammunition. Otherwise, you can take your own ammo for your own gun. Their hours of operation are 11 am to 7 pm. You must have ear and eye protection in order to shoot. They sell them. You will be provided with one target but can purchase more for \$1.50 each. We can reserve multiple lanes if we call the week before. If we are only using one lane, we should call ahead an hour before so they can hold one for us. Many classes are offered for safety, as well as one to obtain your LTC and learn the rules. You may want to inquire about a safety course before you try shooting if you are a novice. The beginner's course is \$50. The course to obtain your license to carry is \$100.

Be proud you are in Texas, where freedom reigns, and this is possible. Not everyone has this so easily available.
