## Communicating With Elected Officials

- Put yourself in the place of the elected official and their staff. “Do unto others as you would have others do unto you.”
- Don’t present your argument or information using your emotions.
- Do your homework. Make sure the information you are presenting is factual.
- Make sure they are the appropriate office for the issue. (City, County, State, Federal)
- Make your argument or present your information in short concise terms.
- Make sure what you are asking the elected official to do is legal under current law.
- Get to know the staff who works with the elected official. Build a relationship.
- Let the elected official hear from you both when they support things you favor and those things you oppose. Delivering “thank you” when appropriate helps you build a good relationship with the staff and elected official.
- Patience. Nothing happens overnight in government – nor should you want it to.

Patience + Strategy = Gratification

Strategy + Patience = Success

Our country and state function within a Constitutional Republic form of government. If we are honest with ourselves and with each other we would admit that we would all like to have a dictator in charge who could just make a decision and it is enforced. We just want to have our own personal dictator that agrees 100% with “me”. We all believe that “I”, “me”, “we”, are the “majority”. Elected officials are elected to represent a large number of constituents. Those constituents do not always have the same interests, values and needs. Many times legislation will help some and possibly have a negative effect on others.

**Making sure your information is factual:** This can be difficult in today's environment where truth has become hard to define.

**Those who control the language control the truth.**

As we become more and more polarized in our country it has become a common practice for people to gravitate to sources of news that agree with what they want to believe. It doesn't help that some who are in power within our government now change the language to force the "facts" to fit within their narrative and plans. An example of this would be changing the definition of when an economy is experiencing inflation or a recession. By changing the conditions necessary for those to occur from how they were always measured, you can declare that you are not experiencing those negative impacts within your economy. Accounting practices applied in different ways can change numbers and outcomes.

Make sure the sources you research are known for using factual information. We can all be deceived and have all been victims of receiving false information. You must do your homework.

Establish a good relationship with the staff in your elected official's office. The staff are responsible for researching legislation and briefing the elected official. Thinking you can only visit or present your case to the elected official will not serve you well. Their staff can help you. Be professional and polite when dealing with them. During session, they will work very long hours and sometimes 7 days a week. They get tired and hear from MANY people. Threats or telling them how much money you donated does not end with positive results.

Sending an email or a letter is encouraged to present your information and/or as a follow-up to a call with the staff or the elected official. Keep it short and concise. They will not read "your book."

- State the correct bill number or state the issue
- Give a brief reason you oppose or support
- Give bullet points or short explanations of support or opposition
- Give your name, address, telephone number and email so you can be contacted

If you are going to be contacting elected officials on a regular basis, you might consider getting an online subscription to something like the Texas State Directory. You would have current updates on state, county and city officials and staff in Texas. You can also purchase a pocket/purse size Texas Legislative Handbook that will contain photos of elected officials, committee assignments, and contact information of all legislators. 2. *Honor & Respect* recommends complimentary close of "Sincerely yours" or "Sincerely."
3. Per *Honor & Respect*, "Representative" and "Senator" are not traditional honorifics for members of the U.S. or Texas House of Representatives or the Texas Senate, but the author notes that many legislators prefer these titles over "Mr./Ms. (Name)." Common use in the Texas legislative community calls for "Representative [name]" and "Senator [name]."

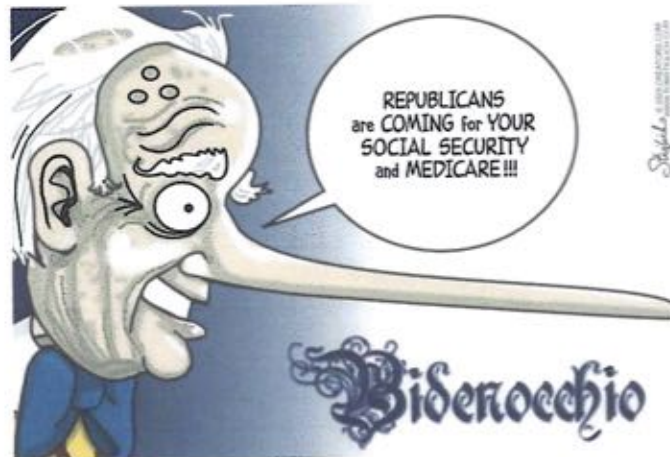


**Membership Report**

## TYPES OF COMMITTEES

### Standing Committees

Standing committees are permanent committees whose jurisdiction is identified in the Texas House Rules.

### Procedural Committees

Procedural committees makes decisions chiefly about legislative process, calendars, or legislative administration in the Texas House.

### Select Committees

Select committees are created by a resolution to review legislation on specific topics and are not renewed on a permanent basis.

## February RWGC Meeting Recap

The speaker at the February meeting was Jackie Schelegel, Executive Director of Texans for Vaccine Freedom. Jackie got interested in vaccine issues when her eldest daughter became medically handicapped after receiving 9 vaccinations in one day at 4 months of age. The current vaccine schedule recommends 78 doses before the age of 18. The 1986 National Vaccine Injury Act protects vaccine manufacturers from liability for damages from Vaccinations. In 2021, as a direct result of Jackie and her organization working diligently to educate Texas legislators, the Texas House and Senate unanimously passed a bipartisan medical-protection bill, and Gov. Abbott signed into law a ban on vaccine passports. Jackie has 5 legislative priorities for the 2023 Texas Legislative Session, #1 being Transparency and Accountability of Covid-19 Vaccines. She asked us to urge Bryan Hughes to file Bill #2 on her list of priorities. For further info, see [www.texansformedicalfreedom.org](http://www.texansformedicalfreedom.org)

Top 5 Legislative Priorities Ms. Schelegel shared:

1. Transparency and Accountability of Covid-19 Vaccines: *Burrows HB 1313/ Springer SB 403*
  - Relating to a study on the side effects, adverse reactions, including death, and the effectiveness of vaccines against the SARS-CoV-2 virus or its variants.
2. Protect Religious and Medical Contraindications Exemptions for Covid-19 Vaccines: *House Bill Pending/Senate Bill Pending*
  - Relating to prohibited COVID-19 vaccine mandates and vaccination status discrimination and to exemptions from certain vaccine requirements.
3. Protect Informed Consent: *Harrison HB 81/ Middleton SB 177*
  - Relating to informed consent before the provision of certain medical treatments involving COVID-19 vaccination.
4. Expand Access to Care: *Swanson HB 44/(pending Senate Sponsor)*
  - Relating to provider discrimination against a Medicaid recipient or child health plan program enrollee based on immunization status.
5. Protect Religious Vaccine Exemptions: *Cain HB 1419/ (Pending Senate Sponsor)*
  - Relating to the repeal of certain limitations on bacterial meningitis vaccination exemptions for students at institutions of higher education
